Item No.3: To consider and decide on the letters/representations received.

a) Letter dated 9th September 2011 received from Directorate of Sports and Youth Service, Pune indicating approval to the admissions of B.P.Ed/M.P.Ed courses, Academic Year 2010-11.

Samiti perused the letter under reference.

The letter under reference indicates that 4773 admissions done in B.P.Ed./M.P.Ed. Colleges for AY. 2010-11 are approved. Samiti noted it, with the following observations :-

1. Total admissions done as provided by rule 10.8 & 10.9 of the brochure 2010-11 approved by Pravesh Niyantaran Samiti in B.P.Ed.,M.P.Ed. courses are 789 & 97 against expected 4430 & 476 respectively. This needs to be properly explained.
2. Total admissions done as provided by rule 10.11 of the brochure 2010-11 approved by Pravesh Niyantaran Samiti in B.P.Ed.,M.P.Ed. courses Outside of Maharashtra State candidates 3488 & 149 against expected 90 and 10 respectively. This needs to be properly explained.
3. List of Colleges (B.P.Ed.,M.P.Ed.) provided by Maharashtra Sharirik Shikshanshastra Vyavasthapan Mahasangh, Jalgaon and that is supplied by Directorate while approving the admissions do not match. This also needs to be clarified.
4. List provided by Directorate while approving the admissions indicate 74 (B.P.Ed.) and 18 (M.P.Ed.) Colleges, however 29 B.P.Ed. Colleges and 9 M.P.Ed.Colleges from the said list only have finalized their Tution fees from Shikshan Shulka Samiti. An explanation from the defaulter colleges and also from the Mahasangh needs to be provided. As far as these defaulter colleges are concerned Samiti with holds their approval.
5. Maharashtra Sharirik Shikshanshastra Vyavasthapan Mahasangh, Jalgaon has not submitted the list of CET centres as per the terms & conditions laid down by office letter dated 28/5/2011. Mahasangh needs to clarify this to Samiti within 15 days.
6. Mahasangh also failed to submit the result of CET-2010 to Samiti as per the terms & conditions laid down by office letter dated 28/5/2010. Mahasangh needs to be clarify this to Samiti within 15 days.

b) Letter dated 10th September 2011 received from Shree Ramchandra College of Engineering, Pune requesting to admit without MH-CET candidates for first year B.E. Course for Academic Year 2011-12.

Samiti perused the letter under reference.

After deliberation, Samiti directs the Institute to be guided by rules & regulations laid down by Directorate of Technical Education in their Brochure 2011-12.



- c) **Letter dated 6th September 2011 received from Association of Unaided Private Pharmacy College, Wardha asking to conduct additional CET for vacant seats of M.Pharm. course for Academic Year 2011-12.**

Samiti perused the letter under reference.

After deliberation Samiti decides not to accede to the request made by Association, in view of the fact that the cut-off date is already over.

- d) **Letter dated 7th September 2011 received from Dr. Raifq Zakaria Campus, Y.B. Chavan College of Pharmacy, Aurangabad requesting their participation in M.-Pharm-AMPCMACET-2011& CAP- 2011 process for filling 04 Minority seats remaining vacant for Academic Year 2011-12.**

Samiti perused the letter under reference.

After deliberation Samiti permits the institute to join the CAP – 2011 process in M.Pharm AMPCMACET-2011 admissions for the Academic Year 2011-12.

- e) **Letter dated 25th August 2011 received from Dr. Arun Mothare College of Management (MBA), Bhandara asking to permit admissions on the basis of AMMI-CET-2011.**

Samiti perused the letter under reference.

After deliberation, Samiti directs the Institute to be guided by rules & regulations laid down by Directorate of Technical Education in their Brochure 2011.

Item No. 4: To consider and decide on the complaints received:-

- a) **Letter dated 2th September 2011 received from Neelima Khandelwal, Mumbai about the admission of Ms. Chhavi Vijay Khandelwal for B. Architecture course for Academic Year 2011-12.**

Samiti perused the letter under reference.

After deliberation, Samiti directs the colleges i.e. KRIVIA, L.S.Raheja, IES and Rizvi College of Architecture to submit details of admission processes and the claim of claimant made out in her letter under reference. After receipt of the reply from Colleges/Institutes same to be placed before Samiti for its consideration.

- b) **Letter dated 13th September 2011 received from Qureshi Mohd. Tahir raising grievances for admission in M. Pharmacy in Allana College of Pharmacy, Pune on merit basis of AMPCMA-CET-2011 in Minority Quota.**

Samiti perused the letter under reference.

Samiti heard the candidate's parents.

After deliberation, Samiti directs Allana College of Pharmacy, Pune to submit the report before Samiti about the complaint received from Qureshi Mohd. Tahir. Same to be placed before Samiti.

Item No. 5: Any other matter with the permission of the Chair.**a) To consider and decide on letter dated 07/09/2011 received from Shailesh Kejriwal complaining the admission process of B.Architecture course in L.S. Raheja and Bhausaheb Hiray Architecture College.**

Samiti perused the letter under reference.

After deliberation, Samiti directs Colleges i.e. L.S. Raheja and Bhausaheb Hiray Architecture College to submit details of admission process and explanation against the complaints received from Shailesh Kejriwal. Same to be placed before Samiti.

b) Letter dated 07/08/2011 received from Ramrao Adik Institute of Technology in respect of decision taken by Samiti in its meeting held on 9th August 2011 [at Item No. 4(b)] regarding admission through Institute level quota.

Samiti perused the letter under reference.

In view of the reply of the Institute, Samiti decides to dispose off the complaint of Prashant Waikar.

c) Letter dated 16/9/2011 received from IES College of Architecture regarding Merit list of students admitted in the first year AY 2010-11 submitted to Director of Technical Education, Mumbai.

Samiti perused the letter under reference.

Samiti directs Director, Directorate of Technical Education, Mumbai to verify and submit the report to Samiti within a fortnight.


d) Letter dated 13/9/2011 received from Maharashtra Vinaanudan Adhyapak Mahavidyalaya Sansthachalak Association submitting the list of New Member Colleges for Information.

Samiti perused the letter under reference indicating inclusion of following colleges in CAP process 2011-12 for B.Ed. and M.Ed. courses.
