Item No. 3: To consider and decide on the letters/representations received:-

- a) **Letter dated 3rd October 2011 received from Shradha Mahadev Kale against Dr. V.V. Patil Medical College, Ahmednagar regarding her claiming admission and reply received from the said institute dated 21/10/2011.**

Samiti perused the letters under reference.

It is observed that the aforesaid College/Institute vide its letters dated 21/10/2011 and 3/11/2011 have informed that the reference number of the Caste Certificate and Caste Validity Certificate of Kum. Shradha Kale does not match; therefore, her name was included in "incomplete list." Therefore her complaint was not genuine.

In view of the above, after deliberation Samiti accordingly, rejects the claim of said Shradha Mahadev Kale.

- b) **Letter dated 17th October 2011 received from Post Graduate Institute of Swasthiyog Prtishthan, Miraj requesting to enlist it with Government CET for its Post Graduate course.**

Samiti perused the letter under reference.

After deliberations. Samiti directs the aforesaid College/Institute to join CET conducted by Directorate of Medical Education and Research, Mumbai of Government of Maharashtra and to follow CET rules as per Government policy, subject to final approval/affiliation/permissions from respective Authorities.



- c) **Letter dated 28th September 2011 received from Kum. Sneha Sanjay Shinde asking for treating her admission as 'Open' (Academic Year 2010-11 for B.H.M.S. course.)**

Samiti perused the letter under reference.

After deliberation, Samiti directs the aforesaid College/Institute to follow the decision taken by the Samiti in its meeting held on 19th October 2011 (at Item No. 3[d]). Samiti advises the institute to go by it.

- d) **Letter dated Nil received from parents of Guardian Dental college, Thane requesting to shift the students from Guardian College of Dental Sciences, Ambarnath to other Dental College, addressed to Secretary, Govt. of Maharashtra, copy enclosed to us.**

Samiti perused the letter under reference.

It is observed that the communication is address to the Secretary, Medical Education and Drugs Department, Government of Maharashtra and copy is endorsed to us.

After deliberation, Samiti reiterates that transfer of the students to another colleges does not come within the purview of Samiti. Appropriate decision needs to be taken by the appropriate Authorities.

Item No. 4: Any other matter with the permission to the Chair.

- a) **Letter dated 17th November 2011 received from Sonajirao Kshirsagar Homeopathic Medical College, Beed in respect of the decision taken by the Samiti in its meeting held on 19th October 2011 along with the office note signed by Hon'ble Chairman.**

Samiti perused the letter under reference, and also the circulatory note cited above.

After the deliberation, Samiti ratifies the orders passed by Hon'ble Chairman. Samiti further directs that the said permission is granted only for the Academic Year 2011-12 and the Colleges/Institutes should not treat it as a precedent for the years to come.

- b) **Letter dated 29th November 2011 received from Maharashtra University of Health Sciences, Nashik in respect of the decision taken by the Samiti in its meeting held on 26/09/2011 (at Item No. 7(i)) regarding admission of Dr. Manisha Choudhari admitted for M.D. Homoeopathy course for the Academic Year 2010-11 at Dr. M.L. Dhawale Homoeopathic Medical Colleg, Palghar.**
